7. **Declaration:** The applicant declares that the deceased was a Zarathushti, following and practising the Zarathushti religion propounded by Asho Zarathushtra. He further understands that the final funeral rights and ceremonies will only be conducted according to Zarathushti customs and rituals at the funeral home, cemetery or crematorium. In the case of a deceased non-Zarathushti spouse, the applicant solemnly declares that the deceased did not practise any other religion, and understands that the final funeral rights and ceremonies will only be conducted according to Zarathushti customs and rituals at the funeral home and cemetery.
8. **Financial Declaration:** The applicant undertakes to bear all expenses of the burial or cremation of the deceased and make payments thereof to the Valley View Memorial Gardens and the funeral director of the crematorium either directly or through The Zoroastrian Society of British Columbia.
9. **Burial Lots:** The burial lots in the Garden of the Four Prophets and the Garden of Atonement of the Valley View Memorial Gardens in Surrey, British Columbia, in the Zoroastrian Section, are the property of The Zoroastrian Society of British Columbia. The Society has the sole right to the selection of the lot for burial or for interment of cremated remains. Lots will be allotted one after the other and will be on a line-by-line basis.

These will be removed by the caretaker of the Valley View Memorial Gardens when their condition is considered by him to be detrimental to the beauty of the cemetery.
12. The Society is in no way responsible, either legally or financially, for the arrangements that have been requested.
13. The applicant affirms that he/she has provided the above information conscientiously, believing it to be true; that he/she is legally entitled to make this declaration, and that the Society has no other recourse but to rely on this declaration.
